Jaquith Public Library, 122 School Street, Marshfield

Serving days are Wednesday July 10, 17, 25 and 31, 2019
Public lunch service time is 11:30 am. until 12:15 pm.
Breakfast service is not available at this site.

Twinfield Union School, 106 Nasmith Brook Road, Marshfield

Serving days are Monday through Thursday, beginning July 8 until August 1, 2019
Public breakfast service time is 9 am. until 9:45 am.
Public lunch service time is 11:30 am. until 12:15 pm.

Walden School, 135 Cahoon Farm Road, West Danville

Serving days are Monday through Thursday, beginning July 8 until August 1, 2019
Public breakfast service time is 8 am. until 8:30 am.
Public lunch service time is 11:30 am. until Noon.
